RECIPE OF THE MONTH

Hearty Turkey & Vegetable Soup



As we slide into Fall, this is an easy and tasty soup recipe:

Ingredients:

- 1 lb ground turkey breast
- 1 large white onion
- 1 package of Hidden Valley original ranch salad dressing & seasoning mix (1.25 oz)
- 1 package of taco seasoning (1.25 oz)
- 1 can of pinto beans (15 oz)
- 1 can of hot chili beans (15 oz)
- 1 can of whole kernel corn (15 oz)
- 1 can of stewed Mexican-styled tomatoes (15 oz)
- 1 can of stewed tomatoes (any style) (15 oz)

Chop the whole white onion and add to pot with ground turkey breast. Brown the meat with onions. Drain excess liquid after the meat is brown.

Mix both the Hidden Valley ranch salad dressing & seasoning mix and taco seasoning into the meat and onions. Do not drain excess liquid after this point.

Add remaining ingredients and let simmer for one (1) hour.

Hurricane Claims

Now that it is September, hurricane season is upon us. Hopefully, we have a light season with either minimal or no storms. However, whether we have one this year or another, living in a Hurricane Alley, it is inevitable that we will soon be facing a tropical storm or hurricane in the not so distant future. This time of year, it is imperative that anyone who owns a home check their homeowners and windstorm policies to make sure that they have enough coverage. In Florida, if a tropical storm is in the Gulf of Mexico, it is too late to get a policy as insurance companies do not write policies when there is a storm in the Gulf. The time to check your policy is before the storm comes.

When looking at your policy, make sure you have adequate coverage to replace your home in the event of a total loss. You may want to speak with a contractor who can advise you as to what the cost to rebuild your home would be. Additionally, look at assisted living expenses coverage to see whether you have enough available to allow you to pay your living expenses including possibly rent and storage. Another important coverage to review is for personal property replacement. Check to see whether your policy covers replacement or actual cash value for your personal possessions. Also, if you have any unique or exceptionally valuable possessions, be sure to tell your agent so that they can secure special coverage or riders for these items.

Dealing with insurance companies after a storm can be difficult. If there is a storm headed your way, document the condition of your home and possessions by walking through the house taking video or pictures. This documentation will be valuable if the insurance company claims your home was in bad condition before the storm. It also will support your personal possession claims. After the storm, contact your insurance company immediately to make a claim. You may want to contact a contractor for a repair estimate to compare to the insurance company's offer as well. Insurance companies are in the business of saving money, so they are unlikely to pay you full value unless you have good documentation.

Emergency! Here's What Surgery You Could Face in the Hospital

No one wants to be rushed to the hospital for emergency surgery, but if you are, chances are it's for one of these seven procedures that account for 80 percent of all emergency surgeries performed in the United States:

- Removal of part of the large intestine
- Removal of part of the small intestine
- Removal of gallbladder
- Stomach ulcer surgery
- Removal of scar tissue from the abdomen
- Removal of appendix
- Abdominal exploration

A study in the Journal of the American Medical Association (JAMA) noted that emergencies accounted for 11 percent of all surgeries performed and 50 percent of surgical deaths over a four-year period.
