#### RECIPE OF THE MONTH Chili



As it's getting colder, try this amazing chili dish.

#### Ingredients:

- 3 lbs. boneless chuck (1-inch cubes)
- 4 cups rice (cooked)
- 16 oz. beef broth/stock
- 16 oz. can of pinto beans
- 4 tbsp. chili powder
- 3 tbsp. flour
- 2 tbsp. vegetable oil
- 1 tbsp. oregano

#### **Directions:**

- 1 Heat oil in a 4-quart pan over medium heat. Once up to temp, add beef and seer until mostly cooked.
- **2** Add garlic and lower heat.
- **3** Sprinkle the chili powder, cumin, flour, and oregano over the meat. Stir until evenly coated.
- 4 Add beef broth/stock and stir until well blended.
- **5** Add salt and pepper to taste.
- 6 Bring to boil. Stir occasionally.
- 7 Reduce heat and simmer for 2 hours.
- 8 Cover and refrigerate overnight (or you can eat right away, but cooling overnight makes it taste better).
- 9 Reheat and add the beans.

If you do not have time to cool the chili in the refrigerator, add the beans at the point it simmers for 2 hours. Serve over rice. You can add a spoon of sour cream and lime wedge if you would like.

#### **Community Spotlight: Pensacola Cooks Kitchen (PCK)**

Carrie threw me a great 45<sup>th</sup> birthday party at Pensacola Cooks Kitchen (PCK) which is on the west side of Pensacola on Barrancas Avenue. PCK is a great restaurant that also offers cooking classes.

Carrie planned a Cajun cooking class on a Saturday night. We had 13 people at the party, and the great people at PCK taught an interactive class where all of us got to do some hands on cooking. The menu was Cajun fried eggplant, crawfish salad, chicken and sausage jambalaya, and bread pudding. #### Practice Area: Changes May Be Coming to Florida's Insurance Laws

Florida has an unusual law in its *No Fault Motor Vehicle Insurance Act*. Florida law requires that every driver carry \$10,000 worth of insurance to cover his or her own medical bills in an accident.

While this law applies regardless of who is at fault, it is generally insufficient to cover someone's medical bills after a car wreck. Additionally, Florida has no law requiring drivers to have bodily injury insurance to cover claims if they cause an accident. This lack of mandatory bodily injury coverage means that if someone runs a red light and injures you, that person does not have to have insurance to cover your injuries.

The Florida House of Representatives looks as if it will be passing a bill that will eliminate this no fault, or Personal Injury Protection ("PIP") law. Under the proposal, PIP end and will be replaced with mandatory bodily injury coverage. Additionally, the limits will be \$25,000 which will go a lot further than under the old law. At the time of this writing, the entire house had not voted on the bill, but the news is exciting for those of us who believe it is time for a change in Florida law.

#### **Unexpected Consequences**

### **Be Safe on Your Bicycle!**

Bicyclist deaths have risen significantly in recent years, and adult men, not kids, are most often the victims, according to the MedlinePlus website. In 2015, the most recent year figures are available, biking deaths rose 12 percent. Of the 818 fatalities in 2015, a hefty 85 percent were men, with an average age of 45.

A report by the Governors Highway Safety Association noted that bikers often believe they have the right of way and are unable stop in time to avoid a collision. Drivers also often don't see bikers until it's too late.

Intersections aren't the most dangerous area. Seventy-two percent of bicycle fatalities occur away from intersections. More than half take place between 6pm and 6am.

Alcohol, whether consumed by the biker or the driver, is also a factor in 37 percent of collision deaths.
