Spinach Casserole



When Carrie and I got married, some friends and family got together and threw a recipe shower where people brought their favorite recipes and put together a recipe book for us. We still have the recipes and use many of them to this day. They are some of our favorite recipes and are treasured keepsakes from friends. This recipe is easy to make. Our good friend, Ann Chenevert, whose son Jeremy is one of my best friends and was a groomsman in our wedding, gave us this recipe 18 years ago!

Ingredients:

- Two 10 oz packages of frozen chopped spinach
- 1/2 cup of evaporated milk (or half and half)
- 2 tbsp. butter
- 1 tbsp. flour
- 8 oz Velveeta
- 1/2 tsp garlic salt
- Dash cayenne pepper
- Salt and pepper to taste
- 1/4 cup of onions (chopped and sautéed)
- 1 cup bread crumbs

Directions:

Grease a casserole dish. Cook spinach. Drain water, reserving 1/2 cup of the spinach water. Make a white sauce with flour, butter, and milk. Stir in the remaining ingredients, except the bread crumbs, adding spinach last. Pour into casserole dish. Top with bread crumbs.

A client asked me how long will my lawsuit take.

Unfortunately, there is no set answer. I have seen cases resolved in a very short matter of weeks and I have a case in the office right now that is going on for four years.

If I had to give a safe average for a rough life span of a case with some injuries that are not life threatening, I would average about 6 months if no lawsuit has to be filed.

You may not know that cases can often resolve without a lawsuit being filed.

If a lawsuit has to be filed, then I would say a safe estimate would be about 18 months to resolve the case.

So, as you can see, there is some incentive of saved time by resolving a case without filing a lawsuit in court. However, that is a decision that we will discuss with you in detail before we move forward with filing a suit.

Watch for Signs of 'Sick Building Syndrome'
